Hi Brian,

ACEH is denying CRAs request for an extension of the past due Data Gap Investigation Work Plan and Focused Site Conceptual Model. The purpose of the work plan is to evaluate the extent of FP and dissolved contamination at and downgradient of a residential site. Additionally our review of the case files indicates that the vapor investigation report has not submitted documenting if residents are at risk to vapor intrusion. Please note that ACEH considers this a priority site and therefore submittal of these past due documents is required by December 20, 2013. This is an extension of approximately 2 to 3 months from the dates specified in our directive letter dated July 9, 2013.

Please let us know if there is anything that ACEH can do to help facilitate that these actions are taken.
