Brad,

The site is currently in verification monitoring to monitor progress following on-site excavation and in-situ chemical oxidation. Groundwater concentrations have decreased in on-site wells since remediation but remain elevated in off-site wells. Verification monitoring is continuing to establish clear trends in concentrations and the off-site effects of the remediation. Prior to case closure, development of the site may be possible concurrent with groundwater monitoring. In order to determine whether development is possible, Alameda County Environmental Health (ACEH) would review approved building plans.

The case file can be reviewed on the ACEH website shown below and files are also available on the State Water Resources Control Board GeoTracker website. However, the GeoTracker website may not have all historic documents.
