As we discussed on Monday and this morning, Shell is still working on an access agreement with Signature. As we agreed, we will suspend monitoring of the on-site wells and continue quarterly monitoring off-site wells S-5 and S-6 quarterly (off-site well S-4 will continue to be monitored annually, in second quarter in the future). Since we were not able to schedule monitoring in the second quarter, we will monitor wells S-4, S-5, and S-6 as soon as Blaine Tech Services can fit them into their sampling schedule, and we will provide you with a groundwater monitoring report by August 17, 2015. Future sampling events will be scheduled in late September 2015 and late December 2015 and reports for these events and future events will submitted 45 days following the end of the quarter.

We will also be submitting a well destruction and installation work plan and anticipate conducting the work in late third quarter 2015. The new wells will be developed and sampled as soon as the on-site redevelopment will allow.
