Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Existence of an Unauthorized Release

In January 1979, separate phase petroleum hydrocarbons (SPH) were reported in a BART tunnel under the intersection of 7th Street and Broadway. Product lines at 461 8th Street were tested and a pressure leak was found. The product lines were replaced in January 1979. Laboratory analyses indicated that the SPH detected in the BART tunnel was Shell regular gasoline. Subsequent site investigation activities detected petroleum hydrocarbons in soil and groundwater beneath the site. Based on these results, an unauthorized release or releases appears to have occurred from the UST system.

Responsible Party Identification

Shell Oil Products US is a responsible party for the fuel leak because they were the former business owner, tank owner, and tank operator (Definition 1), were the former property owner (Definition3), and had control of the UST at the time of an unauthorized release (Definition 4).

Wells Fargo Bank is a responsible party because they were the former owner of the property where an unauthorized release occurred (Definition 3).

AFE Broadway 8 LLC is a responsible party because they were the former owner of the property where an unauthorized release occurred (Definition 3).

Broadway Oak Partners LLC is a responsible party because they are current owner of the property where an unauthorized release occurred (Definition 3).
