Ms. Jakub:

Delta and TRC have each made an attempt to locate monitoring well MW-4. TRC tried to locate the well by using a metal detector and digging in the last know location of the well without any success. In addition, Delta had Morrow Surveying survey and mark the well location based on the previous survey data (see attached). As you can see the location is in a new driveway on private property.

What I would like to recommend is that Delta return to the site with a subcontractor using ground penetrating radar to locate the exact position of the well before we attempt to abandoned it. Subsequent to locating the well, Delta and ConocoPhillips (COP) will attempt to gain access to the private property and properly abandoned the well. This will likely take some time and wont be completed prior to the submittal of the required report.
