Dear Responsible Parties:

Alameda County Environmental Health (ACEH) staff has reviewed the case file including the following documents prepared on your behalf by Antea Group (Antea) for the subject site:

- *Pilot Test Evaluation and Additional Assessment Work Plan*, (Work Plan), dated April 29, 2013
- Semi-Annual Monitoring Report First Quarter 2013, dated May 10, 2013
- Site Investigation & Pilot Test Report, dated June 29, 2012

The above mentioned documents present analytical data from the 90-day Plume Stop Pilot Test conducted by Antea in March 2012 and an evaluation of the feasibility of continuing to use the Plume Stop technology at the site. Additionally, the Work Plan outlines Antea's proposed strategy for assessing potential secondary source conditions beneath the site prior to continuation of remediation efforts.

ACEH has evaluated the data and recommendations presented in the above-mentioned reports, in conjunction with the case files, and the State Water Resources Control Board's (SWRCBs) Low Threat Underground Storage Tank Case Closure Policy (LTCP). Based on ACEH staff review, we have determined that the site fails to meet at a minimum the LTCP General Criteria d (Free Product), e (Site Conceptual Model), f (Secondary Source Removal), and the Media-Specific Criteria for Groundwater.

ACEH generally concurs with Antea's strategy to utilize CPT/UVOST technology to help define the horizontal and vertical extent of potential secondary source materials in the subsurface in the vicinity of groundwater monitoring well MW-4. Additionally, although ACEH concurs with Antea's recommendation to replace monitoring well MW-4 due to submerged well screen conditions, ACEH is concerned that submerged well screen conditions in other wells within the site's monitoring well network have not been addressed and as a consequence the site hydrogeology and contaminant fate and transport is not understood. Therefore, prior to implementing the proposed scope of work, ACEH would like to invite you and your consultant to a meeting at our office to discuss the technical comments below. Please email us by **July 19, 2013** with proposed dates and times for the meeting.

TECHNICAL COMMENTS

- 1. Plume Stop Pilot Test The Work Plan presents the results of the March 2012 field testing conducted by Antea in collaboration with Regenesis of a new groundwater remediation technology to assist in the immobilization and remediation of total petroleum hydrocarbons present in groundwater at the site. Based on post-remediation groundwater monitoring results, Regenisis concludes that an additional hydrocarbon mass was disturbed/desorbed by the injection of the Plume Stop material and thus the pre-application baseline data does not represent the full nature and/or extent of the hydrocarbon mass present. ACEH notes that pilot testing of this new untested technology was conducted by Antea and Regenesis without regulatory approval and is concerned with the apparent mobilization of the hydrocarbon mass, and the potential inability of the site's monitoring well network to detect potentially related free product migration and produce representative contaminant concentration data due to submerged well screens as described in Item 2 below.
- 2. Groundwater Monitoring Well Network In the Work Plan Antea states that comparison of monitoring well MW-4's screen interval and the typical depth to water recorded at this well since it's installation in 1992 indicates that the screened interval of MW-4 is likely submerged most of the year and therefore, hydrocarbon concentrations previously reported in this well may not be representative due to the submerged screen conditions.

Based on ACEH's review of the well construction details and historic groundwater gauging data for monitoring well MW-4, we concur that well MW-4 is submerged as the well is screened from 20 to 40 feet below ground surface (bgs) and historic depth to water measurements have ranged from 13.52 to 31.98 feet bgs.

However, our review of the well construction details and historic groundwater gauging data for other wells indicates that submerged conditions are not confined to monitoring well MW-4, but also exist in nine other wells located both on-site and off-site including MW-1, MW-2, MW-3, MW-6, MW-7, MW-8, MW-9, EX-1, and EX-2. ACEH is concerned that previously reported hydrocarbon concentrations and lack of free product observations in these additional wells, and interpreted groundwater flow gradients may not be representative of site conditions. Therefore, ACEH requests you conduct an evaluation of submerged well screen conditions in all the wells in the groundwater monitoring well network to determine whether additional wells should be replaced.

3. Site Conceptual Model – According to the LTCP, the SCM is a fundamental element of a comprehensive site investigation. The SCM establishes the source and attributes of the unauthorized release, describes all affected media (including soil, groundwater, and soil vapor as appropriate), describes local geology, hydrogeology and other physical site characteristics that affect contaminant environmental transport and fate, and identifies all confirmed and potential contaminant receptors (including water supply wells, surface water bodies, structures and their inhabitants). The SCM is relied upon by practitioners as a guide for investigative design and data collection. All relevant site characteristics identified by the SCM shall be assessed and supported by data so that the nature, extent and mobility of the release have been established to determine conformance with applicable criteria in this policy.

As discussed above, our review of the case files indicates that insufficient data and analysis has been presented to assess the nature, extent, and mobility of the release. Therefore, please prepare a focused SCM to address these data gaps and include in the SWI report described in Item 4 below.

- 4. Soil and Water Investigation Report and Focused Site Conceptual Model (SCM) Please present the results of the CPT/UVOST investigation and the replacement of submerged monitoring wells with appropriately screened wells in a Soil and Water Investigation Report by the due date requested below. Include a synthesis of the data in a tabular SCM that identifies remaining data gaps, if any. Please refer to Attachment A for an example of a tabular SCM and requisite SCM elements.
- Groundwater Monitoring Please conduct quarterly groundwater monitoring events to continue to monitor the post-injection groundwater concentration trends and submit reports by the dates requested below. Please include naphthalene in the suite of analysis.

REPORT/DATA REQUESTS

These reports/data are being requested pursuant to Division 7 of the California Water Code (Water Quality), Chapter 6.7 of Division 20 of the California Health and Safety Code (Underground Storage of Hazardous Substances), and Chapter 16 of Division 3 of Title 23 of the California Code of Regulations (Underground Storage Tank Regulations).

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (Local Oversight Program [LOP] for unauthorized releases from petroleum Underground Storage Tanks [USTs], and Site Cleanup Program [SCP] for unauthorized releases of non-petroleum hazardous substances) require submission of reports in electronic format pursuant to Chapter 3 of Division 7, Sections 13195 and 13197.5 of the California Water Code, and Chapter 30, Articles 1 and 2, Sections 3890 to 3895 of Division 3 of Title 23 of the California Code of Regulations (23 CCR). Instructions for submission of electronic documents to the ACEH FTP site are provided on the attached "Electronic Report Upload Instructions."

Submission of reports to the ACEH FTP site is in addition to requirements for electronic submittal of information (ESI) to the State Water Resources Control Board's (SWRCB) Geotracker website. In April 2001, the SWRCB adopted 23 CCR, Division 3, Chapter 16, Article 12, Sections 2729 and 2729.1 (Electronic Submission of Laboratory Data for UST Reports). Article 12 required electronic submittal of analytical laboratory data submitted in a report to a regulatory agency (effective September 1, 2001), and surveyed locations (latitude, longitude and elevation) of groundwater monitoring wells (effective January 1, 2002) in Electronic Deliverable Format (EDF) to Geotracker. Article 12 was subsequently repealed in 2004 and replaced with Article 30 (Electronic Submittal of Information) which expanded the ESI requirements to include electronic submittal of any report or data required by a regulatory agency from a cleanup site. The expanded ESI submittal requirements for petroleum UST sites subject to the requirements of 23 CCR, Division, 3, Chapter 16, Article 11, became effective December 16, 2004. All other electronic submittals required pursuant to Chapter 30 became effective January 1, 2005. Please visit the SWRCB website for more information on these requirements. PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 7835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, late reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

Site Conceptual Model

The site conceptual model (SCM) is an essential decision-making and communication tool for all interested parties during the site characterization, remediation planning and implementation, and closure process. A SCM is a set of working hypotheses pertaining to all aspects of the contaminant release, including site geology, hydrogeology, release history, residual and dissolved contamination, attenuation mechanisms, pathways to nearby receptors, and likely magnitude of potential impacts to receptors.

The SCM is initially used to characterize the site and identify data gaps. As the investigation proceeds and the data gaps are filled, the working hypotheses are modified, and the overall SCM is refined and strengthened until it is said to be "validated". At this point, the focus of the SCM shifts from site characterization towards remedial technology evaluation and selection, and later remedy optimization, and forms the foundation for developing the most cost-effective corrective action plan to protect existing and potential receptors.

For ease of review, Alameda County Environmental Health (ACEH) requests utilization of tabular formats to (1) highlight the major SCM elements and their associated data gaps which need to be addressed to progress the site to case closure (see Table 1 of attached example), and (2) highlight the identified data gaps and proposed investigation activities (see Table 2 of the attached example). ACEH requests that the tables presenting the SCM elements, data gaps, and proposed investigation activities be updated as appropriate at each stage of the project and submitted with work plans, feasibility studies, corrective action plans, and requests for closures to support proposed work, conclusions, and/or recommendations.

The SCM should incorporate, but is not limited to, the topics listed below. Please support the SCM with the use of large-scaled maps and graphics, tables, and conceptual diagrams to illustrate key points. Please include an extended site map(s) utilizing an aerial photographic base map with sufficient resolution to show the facility, delineation of streets and property boundaries within the adjacent neighborhood, downgradient irrigation wells, and proposed locations of transects, monitoring wells, and soil vapor probes.

- a. Regional and local (on-site and off-site) geology and hydrogeology. Include a discussion of the surface geology (e.g., soil types, soil parameters, outcrops, faulting), subsurface geology (e.g., stratigraphy, continuity, and connectivity), and hydrogeology (e.g., water-bearing zones, hydrologic parameters, impermeable strata). Please include a structural contour map (top of unit) and isopach map for the aquitard that is presumed to separate your release from the deeper aquifer(s), cross sections, soil boring and monitoring well logs and locations, and copies of regional geologic maps.
- b. Analysis of the hydraulic flow system in the vicinity of the site. Include rose diagrams for depicting groundwater gradients. The rose diagram shall be plotted on groundwater elevation contour maps and updated in all future reports submitted for your site. Please address changes due to seasonal precipitation and groundwater pumping, and evaluate the potential interconnection between shallow and deep aquifers. Please include an analysis of vertical hydraulic gradients, and effects of pumping rates on hydraulic head from nearby water supply wells, if appropriate. Include hydraulic head in the different water bearing zones and hydrographs of all monitoring wells.
- c. Release history, including potential source(s) of releases, potential contaminants of concern (COC) associated with each potential release, confirmed source locations, confirmed release locations, and existing delineation of release areas. Address primary leak source(s) (e.g., a tank, sump, pipeline, etc.) and secondary sources (e.g., high-

concentration contaminants in low-permeability lithologic soil units that sustain groundwater or vapor plumes). Include local and regional plan view maps that illustrate the location of sources (former facilities, piping, tanks, etc.).

- d. Plume (soil gas and groundwater) development and dynamics including aging of source(s), phase distribution (NAPL, dissolved, vapor, residual), diving plumes, attenuation mechanisms, migration routes, preferential pathways (geologic and anthropogenic), magnitude of chemicals of concern and spatial and temporal changes in concentrations, and contaminant fate and transport. Please include three-dimensional plume maps for groundwater and two-dimensional soil vapor plume plan view maps to provide an accurate depiction of the contaminant distribution of each COC.
- e. Summary tables of chemical concentrations in different media (i.e., soil, groundwater, and soil vapor). Please include applicable environmental screening levels on all tables. Include graphs of contaminant concentrations versus time.
- f. Current and historic facility structures (e.g., buildings, drain systems, sewer systems, underground utilities, etc.) and physical features including topographical features (e.g., hills, gradients, surface vegetation, or pavement) and surface water features (e.g. routes of drainage ditches, links to water bodies). Please include current and historic site maps.
- g. Current and historic site operations/processes (e.g., parts cleaning, chemical storage areas, manufacturing, etc.).
- h. Other contaminant release sites in the vicinity of the site. Hydrogeologic and contaminant data from those sites may prove helpful in testing certain hypotheses for the SCM. Include a summary of work and technical findings from nearby release sites, including the two adjacent closed LUFT sites, (i.e., Montgomery Ward site and the Quest Laboratory site).
- i. Land uses and exposure scenarios on the facility and adjacent properties. Include beneficial resources (e.g., groundwater classification, wetlands, natural resources, etc.), resource use locations (e.g., water supply wells, surface water intakes), subpopulation types and locations (e.g., schools, hospitals, day care centers, etc.), exposure scenarios (e.g. residential, industrial, recreational, farming), and exposure pathways, and potential threat to sensitive receptors. Include an analysis of the contaminant volatilization from the subsurface to indoor/outdoor air exposure route (i.e., vapor pathway). Please include copies of Sanborn maps and aerial photographs, as appropriate.
- j. Identification and listing of specific data gaps that require further investigation during subsequent phases of work. Proposed activities to investigate and fill data gaps identified.
