Thank you for your response and comments indicated below. We are currently in the process of permitting the well destruction of the site wells. Alameda County Environmental Health (ACEH) has reviewed the recently submitted document entitled *Work Plan- Well Destruction and Replacement* (WP) dated May 21, 2014 prepared by Antea Group (ANTEA) on your behalf. ACEH agrees with the well destruction as described in the WP but is of the opinion monitoring well replacement should be determined after the interim removal action has been performed.

The proposed well destruction may be implemented. Replacement well installation may be addressed in the removal action report or submitted under separate cover as a replacement well installation work plan. Please schedule and complete the fieldwork activities by the date specified below and provide ACEH with at least three (3) business days notification prior to conducting the fieldwork. Upon completion of the well destruction, please prove ACEH with documentation of the well destruction and removal of destruction derived waste.
