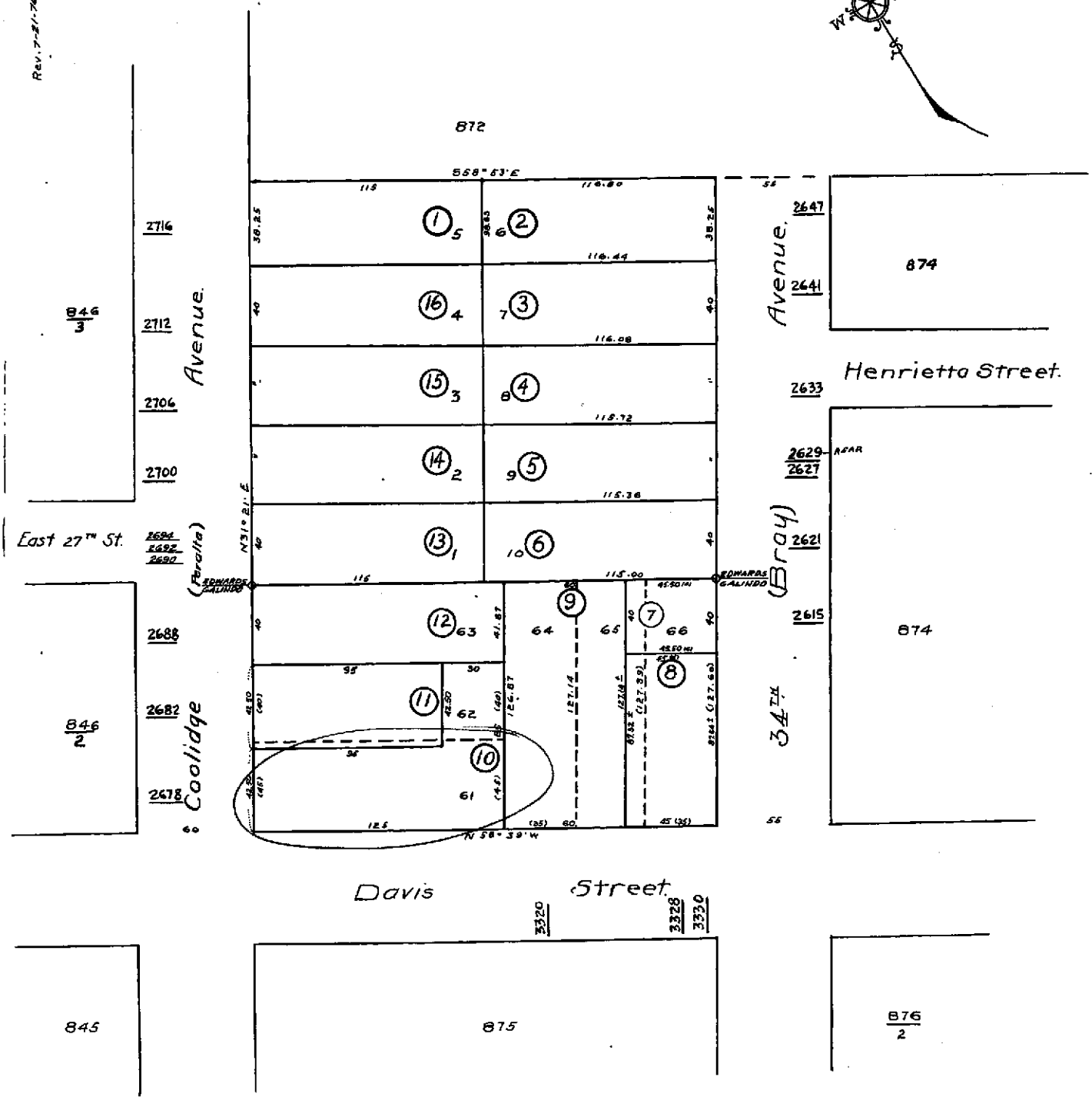
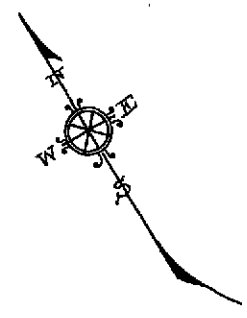
Map of the Galindo Tract - Brooklyn Township. - (Bk. 15 Pg. 62)
