SUBJECT: Alameda County Transportation Corridor (portion of APN 94-110-46-2 east of Ray Street), Pleasanton, CA 94566

Dear Mr. Rory MacNeil:

This letter explains the status of the subject property with respect to groundwater pollution in the vicinity of the property. The subject property is located down-gradient (northwest) from the Shell #135782 at 4212 1st Street, Pleasanton. Petroleum hydrocarbon releases consisting of a mixture of gasoline and MTBE at the Shell site polluted soil and groundwater, with groundwater pollution extending offsite. At this time, it does not appear that the plume from the Shell site extends beneath the former railroad right-of-way that is currently an unoccupied open area. The plume, which is generally 30 to 70 feet below ground surface, is not expected to affect any water supply wells or pose a risk to nearby residents. The Shell #135782 site is an open fuel leak case under the regulatory oversight of Alameda County Environmental Health (ACEH).

Based on information currently available to ACEH staff, we conclude that groundwater pollution detected in the vicinity of the subject property is likely the result of the migration of pollutants in groundwater from the upgradient Unocal site at 4191 1st Street, although potentially there may be impacts from the upgradient Shell site. In general, ACEH does not pursue enforcement action against a property owner whose land overlies contaminated groundwater if that contamination is solely the result of the migration of groundwater contaminants from an off-site source or sources. Accordingly, ACEH will not name current and future owners of the subject property as dischargers with respect to groundwater pollution from offsite sources. However, ACEH may hold such a property owner responsible for investigation or cleanup tasks is if he or she refuses to provide reasonable access to an upgradient discharger attempting to investigate and cleanup off-site groundwater pollution. Access to your property may be required, in the future, in order to conduct cleanup activities for the downgradient petroleum hydrocarbon plume.
