> The proposed remediation for the fuel leak case at 4191 First Street in Pleasanton has not started. Chevron has taken over managment of the remediation from ConocoPhillips and will be submitting a revised remedial design. The cleanup will still use soil vapor extraction as

the primary cleanup method but Chevron is proposing revising equipment and technical parameters.
