Hi Mark,

In the previously submitted *Fourth Quarter 2009 Groundwater Monitoring Report and Sampling Reduction Request* (dated 1/8/10), we had proposed a reduction in the sampling frequency of well MW-14 at site RO368 (Chevron 9-8139 San Leandro) from quarterly to semi-annual. As we haven't heard back to date, I figured I'd send an e-mail. The frequency of the remaining site wells was reduced last year per the State Board Resolution; however, MW-14 remained on a quarterly frequency as requested by ACEH due to an increase in the MTBE concentration during third quarter 2008. Since that event, however, the MTBE concentrations have again decreased and a reduction to semi-annual (Q1 and Q3) appears warranted. This is the only well at the site currently on a quarterly frequency. If you could let me know if this is acceptable to ACEH I would appreciate it. Thanks.
