Scott,

I received your voice mail this afternoon and wanted to respond to your inquiry as to the status of the public comment period for closure of the site. There were no comments received during the 60-day public comment period. You are therefore cleared to proceed with the destruction of all wells associated with the site (groundwater, vapor, etc), as requested in the November 12, 2013 letter from ACEH (copy attached).

The destruction of the wells does not need to be as closely choreographed as the letter indicates. The SWRCB has since clarified it's position for ACEH. Please obtain well destruction permits from ACPWA, let me know the date of the work, and submit a brief letter report with a professional stamp (and perjury statement) describing the work, including documentation of the disposal of all remaining waste generated at the site.
