Thanks for the verbal update on the project. Based on our conversation, ACEH has extended the submittal deadline for the First Remedial Progress report (for well installation) to July 18, 2014. The extension has been largely required due to funding difficulties at the Cleanup Fund. Based on this timeline, the Remedial Progress Report, including as-built details, previously requested by February 17, 2014 has also been extended to August 22, 2014. Please keep ACEH apprised of the project status, and please notify ACEH of any additional delays (funding or other). Additional extensions may be appropriate if additional extenuating circumstances are encountered.
