Hi Mark and Cherie,

On behalf of Chevron Environmental Management Company (Chevron), I'm emailing to find out the status of the above referenced case located at 15595 Washington Avenue in San Lorenzo. Chevron is a secondary RP.

On October 6, 2011 the UST Cleanup Fund 5-year Review Summary recommended the LOP review the site for Closure. However, in November 2011, ACEH disagreed with the recommendation and requested the primary RP (Mohammadian) submit a work plan for additional investigation. In a January 24, 2012 Work Plan, Mohammadian proposed additional work. Then on March 28, 2012, ACEH requested a revised work plan Figure and the investigation be reported "60 days after work plan addendum approval". Nothing has been uploaded to Geotracker since March 28, 2012. Is this site going to be closed or has the work been completed?

Please let me know the closure status of this case.
