Dear Mr. Silberman:

As you are aware, an investigation resulting from underground storage tank leaks was performed at the subject property to which you are named as the primary or active responsible party. Pursuant to Section 25297.15 (a), Alameda County Environmental Health (ACEH), the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACEH is required to notify the primary or active responsible party of their requirement to certify in writing to the local agency that the notification requirement in the above-mentioned regulation has been satisfied and to provide the local agency with a complete mailing list of all record fee title owners.

To satisfy the above-mentioned requirement, please complete the enclosed "List of Landowners Form," and mail it back to ACEH within thirty (30) days from the date of this letter. Also your comments, if any, must be considered prior to the proposed cleanup or closure. Please respond within 30 days from the date of this letter for your comments to be considered.

Additionally, pursuant to California Code of Regulations, Title 23, Division 3, Chapter 16, §2728, ACEH requires notification to the public of the proposed case closure for the site. To that end, ACEH has prepared and will send out the public participation fact sheet (enclosed), which describes the site and previous investigation activities that were conducted to the property addresses listed on the enclosed List of Public Participants. Public comments on the proposed action will be accepted for a period of thirty days beginning Friday March 11, 2011 through Monday April 11 2011.

Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case

at 5515 Doyle Street in Emeryville, California. Tank removal and site investigation activities have been completed by the property owner and it does not appear that the fuel release presents a risk to human health based upon the current commercial land use. Future construction activities or changes in land use will require a re-evaluation of site data.

Background – A 750-gallon UST was removed in August 1994 and two tank bottom samples were collected. The samples, collected at a depth of 8.5 feet bgs, documented concentrations of 4,200 mg/kg TPHg and 0.22 mg/kg benzene. In April 1995 approximately 90 cubic yards of soil were excavated; four sidewall samples and an excavation bottom sample were collected. Concentrations of 5,200 mg/kg TPH as gasoline, 580 mg/kg TPH as diesel, and 24 mg/kg benzene were documented in the excavation bottom

sample, collected at a depth of 9 feet bgs. Excavated soil was disposed at Forward Landfill in Manteca, California. In December 2007 a soil and groundwater investigation report documented the installation of bores SGW-1 to SGW-6 around the former tank excavation. Concentrations up to 1,300 mg/kg TPH as gasoline, 320 mg/kg TPH as diesel, and 0.97 mg/kg benzene were reported in soil, while up to 830 μ g/L TPH as gasoline, 730 μ g/L TPH as diesel, and 24 μ g/L benzene were detected in grab groundwater samples. Soil


samples collected beneath the former UST excavation encountered 4.3 ppm TPHg and 2.8 ppm TPHd at a depth of 11.5 feet bgs.
