As a brief update, we have not yet received a required down payment from the RP to cover the subcontracted permitting, drilling and laboratory analysis fees associated with implementation of the continued data gap investigation work plan activities at the subject property. We are currently reconciling the RP's UST Cleanup Fund account in attempt to recover some pending \$ associated with reimbursement request(s) from the previous fiscal year (15/16) as well as submit a new reimbursement request package for this fiscal year (16/17) which perhaps will aid in payment for the forthcoming subcontracted field activities. We hope to move forward with this phase of investigation work by mid to late September 2017, and request an additional extension of time for submittal of our Data Gap Investigation Report until mid October 2017.
