Our apologies, but we will need to request an additional extension for completion of the field sampling activities and associated site investigation report. Again, we have not yet received the minor encroachment permit from the City of Oakland for the proposed borings along the College Avenue Right of Way. The permit required an updated Grant Deed on the property that was recently issued and submitted to the City. The City is in the process of assigning Encroachment Permit ENMI#15107; once received, we can obtain a City excavation permit, as well as apply for the drilling permit through the Alameda County Public Works Agency (minimum 10-day processing). We hope to complete drilling activities in mid September 2015 and issue a report of findings by mid to late November 2015.
