I am writing to follow-up with our phone conversation we had last week regarding my request for extending the well destruction report deadline that is currently set for April 23, 2012 at Former Exxon 70238 located at 2200 East 12th Street, Oakland, California. Currently, my clients lawyers are working with the City of Oakland on indemnity issues in order to obtain encroachment permits to destroy off-site monitoring wells. The City of Oakland is not renewing the existing encroachment permit to destroy all off-site monitoring wells. After talking with the lawyers, they estimate at least several months to produce insurance documents and provide a self- insurance statement in order for them to obtain the encroachment permits. Based on these time estimates, I would like to extend the report deadline to November 30, 2012.

If you could please follow-up with this email updating the well destruction report deadline statue it would be greatly appreciated.
