As disclosed, BAI will not be in receipt of the missing waste profile analytical results, transportation manifests, and/or disposal receipts until at least early to mid June 2010. Therefore, BAI requests an extension of the due date for submittal of the final Well Decommissioning Report to 6/28/2010.

Hello Paresh, □

Broadbent & Associates is holding onto a nearly complete Well Decommissioning Report for ARCO Station #2185 located at 9800 International Blvd in Oakland corresponding to ACEH Case #RO392. As I informed you in my email of 4/16/2010, the twelve wells associated with ARCO #2185 were formally decommissioned/destroyed during 4/13-15/2010. In the correspondence of 4/16 we had committed to providing your agency with a complete Well Decommissioning Report by 5/28/2010.

I have been informed by Belshire Environmental, that copies of the transportation manifests, disposal tickets (to be at TPST Soil Recyclers of CA), and waste profile analytical results for the wastes generated during decommissioning will not be available until early or mid June (a date yet to be determined by Belshire). Therefore, I would like to offer you the choice:

- 1) In advance of the 5/28/2010 revised due date, BAI could submit the Well Decommissioning Report as is (containing copies of applicable permits, DWR Well Completion Reports/Form 188s, and field notes), with an amended Final report to be submitted after profile results/manifests/disposal tickets are received and can be included; or
- 2) Alternately, wait to submit a single Final Well Decommissioning Report containing all the collected information at an unspecified date sometime in June.

Personally, I have a preference to give you what we have now, showing you that the wells have been abandoned by a C-57 licensed driller in accordance with State and Local requirements. It shows that I take seriously the deadlines your agency sets for compliance. In addition, a partial submittal might allow the case to move forward towards final closure (ACEH preparation of a remedial action completion certificate) until we submit to you the final report.

However, the decision for method of submittal is yours. We look forward to your reply with directions.
