We are moving forward with the injections at RO403 (Former BP 11133). Per the CAP we are going to be monitoring the injections for up to six months which will make it difficult to meet the Report due date in the January 14, 2011 directive of March 11, 2011. Can we get an extension? We were slow to schedule this with our technicians who are not available until mid-March. With 6 months of sampling post injections we would like to submit the report a month after that which would be the end of October (10/28/11). I recognize that is very far off and if it would be better for the agency we could submit a summary report after 3 months of sampling (+1 month) which would be the end of July (7/28), then provide an update once sampling is completed. Is this acceptable?
