One of the frustrating aspects of this job... It is on the short list however...

I would be in agreement that additional groundwater sampling is not necessary until the site can be reviewed. TPHg and all BTEX compounds have been nondetectable for some period of time, only MTBE remains elevated in one well; however, a comprehensive review may suggest reasons or indicate data gaps that might be of concern. Please use this email as approval to suspend groundwater monitoring until that review can occur.
