To access the county database, see the link below. As mentioned there are PDF copies of available reports for all sites including yours that can be downloaded. Likely you'll need to temporarily allow pop ups. Don't use the map that will eventually appear. Use the "search" tab at the top of the blue column on the right, then use the following drop down menus: "LOP Document Search" and "Record ID – RO Number". Then type in the last significant digits of your RO. Most likely a number of cases will pop up, but select yours to see what we have available.

From the most "recent" activity it appears that Chevron is taking a leading role at the site. Unless environmental liability has been fully accepted by one party, a previous site owner retains some environmental liability. Since I'm a new case worker, I don't yet have a working knowledge of all my cases. It may be that liability was accepted by Chevron.
