Hi Mark,

GHD on behalf of Chevron Environmental Management Company (CEMC) would like to request an extension for the *Site Investigation Report and Updated Focused Site Conceptual Model (SIR/SCM)* requested by Alameda County Environmental Health (ACDEH) letter dated February 8, 2018. Access to the properties to the north (4237 Foothill Blvd) and west (1723 High Street) to conduct crawl space and soil vapor investigations, respectively, has been requested. However, to date, access has not been granted by either property owner. To obtain access and conduct the investigations, GHD respectfully requests a new due date of **August 4, 2018** for the SIR/SCM. Below is a summary of access requests to the properties.

4237 Foothill Blvd

Initial site access request was certified mailed on November 10, 2017. Second site access request was certified mailed on January 19, 2018. GHD received signed USPS Return Receipts for each. On January 30, 2018, the property owner contacted the CEMC property specialist with questions and stated they would sign the agreement; however, the signed agreement has not been received to date. On March 1, 2018, GHD emailed the property owner contact information to Mark Detterman.

1723 High Street

Initial site access request was certified mailed to property owner on March 22, 2018. Signed USPS Return Receipt was received April 3, 2018.
