**PUBLIC NOTIFICATION OF POTENTIAL
CASE CLOSURE OF FUEL LEAK CASE
Chevron #9-4930 / Valley Car Wash**

**Site Location: 3369 Castro Valley
Boulevard, Castro Valley, CA 94546**

Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case at the Chipotle Mexican Grill (the former Chevron #9-4930 site), located at the corner of Castro Valley Boulevard and Wilbeam Avenue in Castro Valley, California. On two separate occasions, the property has been occupied by a gasoline service station. The first generation service station existed from 1957 to sometime between 1968 and 1980, when it was reconfigured. The second generation station was present until sometime between 1993 and 1996, when it was replaced with the current building occupying the site.

Background – Site activities have included advancement of sixteen soil borings, installation and monitoring of four groundwater monitoring wells, and installation of three soil vapor sampling in the vicinity of the building currently occupying the site. Site investigations detected 2,500 parts per million (ppm) Total Petroleum Hydrocarbons as gasoline (TPHg) in soil and 23,000 parts per billion (ppb) in groundwater. Benzene was detected up to 800 ppb in groundwater. During station demolition over-excavation of the site was conducted up to 15 fgs.

Post excavation investigations indicate that residual contamination remains in soil up to 990 mg/kg

TPHg, 2.3 mg/kg benzene, and 17 mg/kg ethylbenzene; and in groundwater up to 300 ppb TPHg. Soil vapor samples collected in October 2010 contained up to 21,000 micrograms per cubic meter ($\mu\text{g}/\text{m}^3$) TPHg and 4.8 $\mu\text{g}/\text{m}^3$ benzene which are below the commercial Environmental Screening Levels (ESL) for TPHg in soil vapor.

This fuel leak case has been evaluated for closure consistent with the criteria in the State Water Resource Control Board's Low Threat Closure Policy (LTCP). Sites that meet the general and media-specific criteria in the LTCP are considered to not pose a threat to human health, safety, or the environment and are appropriate for closure pursuant to Health and Safety Code section 25296.10. Residual petroleum hydrocarbons that are present in soil or groundwater are expected to biodegrade over time. With a commercial use restriction, it does not appear that the site presents a risk to human health for site users or residents. Therefore, Alameda County Environmental Health (ACEH) is considering potential closure of the fuel leak case.

Next Step – The public is invited to review and comment on the potential closure of the fuel leak case. 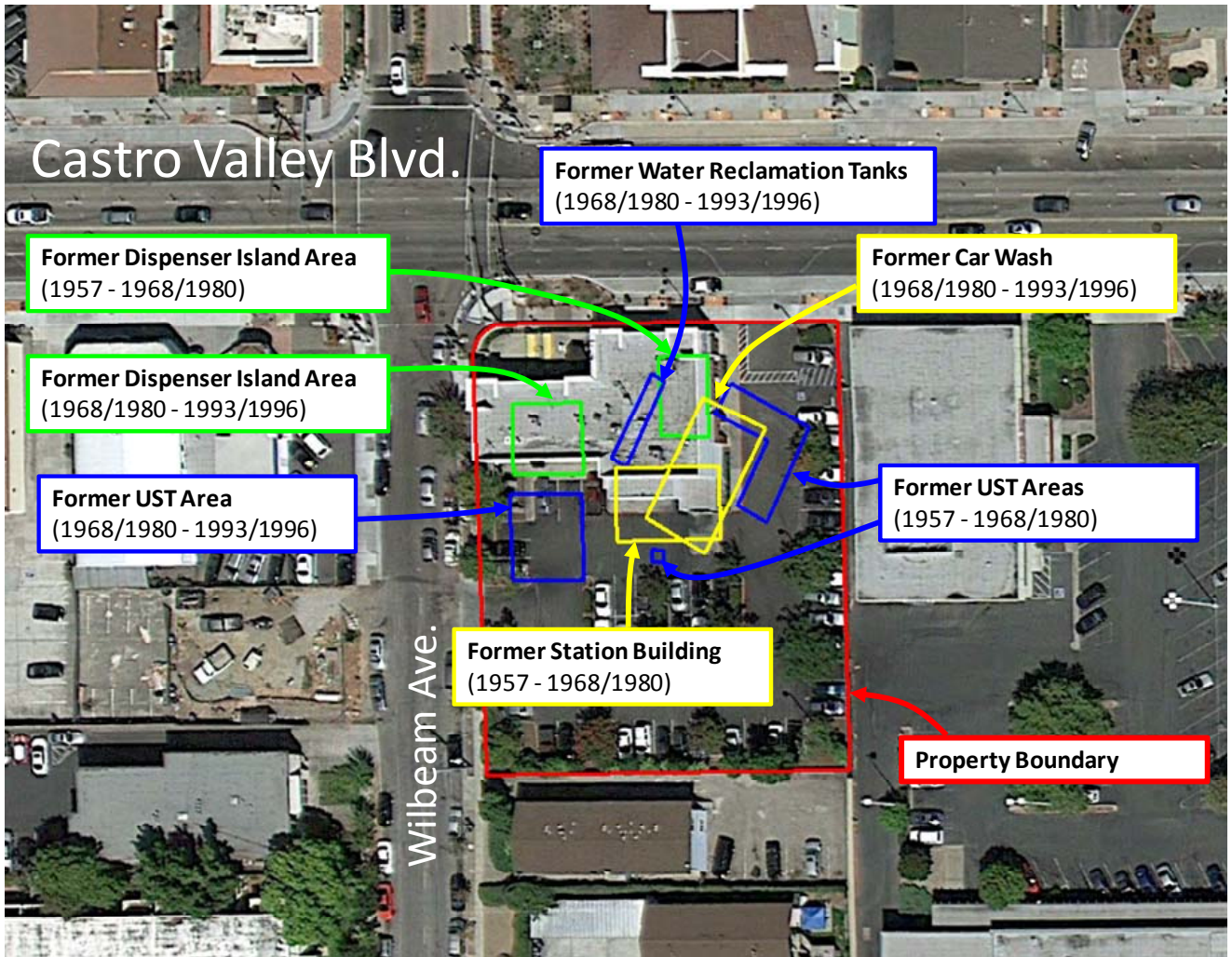


Figure 1: Aerial View of Property (Google Earth, 2013)
