The site at 4035 Park Boulevard in Oakland has a leaking underground fuel case. Alameda County Environmental Health provides regulatory oversight of the fuel leak case under its Local Oversight Program. Corrective actions have been proposed at the site since 2006 but the responsible parties have not implemented the proposed actions. Our most recent directive letter, which is attached, explains the site status. Since the responsible parties have not met the deadlines in the directive letter, we will be sending a Notice of Violation.
