2) The Lynn Nakashima (phone conversation of 11/2/95) contamination associated with UST near the trenching must be excavated now & backfilled with clean fill because of the difficulty in going back in the area of the contamination after the road is built & the utility lines in place.

3) Juan Arreguin agreed if there are remaining contamination, will go back to excavate; awaiting of the analytical results.

4) will meet at Ted Park, Lynn Nakashima when analytical cases is available.
