Following the approval from the Alameda County EMD on June 4, 2008 to complete this project in a split phase approach, we have internally put in place the funding to complete this project. However, our drilling company (Gregg Drilling) has scheduled this work for 9/2/08. We currently anticipate four weeks worth of on site work and will require an additional 45 days to complete the necessary analytical work and the subsequent reports. As such, we are requesting an extension of 120 days (until November 12, 2008) to complete this work and submit the required reports to your office.

ConocoPhillips is committed to ensuring we proactively move forward with this work. Since this will be the second time a system has been installed at this site, we also want to ensure this new system will achieve the remediation goals I believe we mutually share. We appreciate your help and consideration in this matter.

Dennis,

We are willing to consider a schedule extension. However, this site is a groundwater contamination site within the Livermore-Amador valley and must be given a higher priority for completion than apparently given to date. Proposing an open-ended schedule is not acceptable. In our March 21, 2008 correspondence conditionally approving the work plan, we requested that the proposed work be completed by July 22, 2008, a period of approximately 120 days. This was a reasonable schedule for the proposed work. Please propose a schedule extension for report submittal that ConocoPhillips will commit to meeting and that reflects a higher priority for this site.

Mr. Wickham:

As today I have still not received word from ConocoPhillips (COP) to proceed with the installation of the four monitoring wells to a depth of approximately 75 feet bgs and the four monitoring wells to a depth of approximately 45 feet bgs at the above referenced site. I received an email from Mr. Bill Borgh, site manager, COP last week indicating that he was waiting for management approval for the funds necessary to complete this work. This is necessary due to the large dollar amount of the required work.

Because of this, COP and Delta are not going to be able to complete the required work by your requested deadline of July 22, 2008. Therefore, I would like to request an extension. To when, I currently don't know. As soon as I receive the OK from COP to proceed I will have a better idea of when I will be able to submit the required report. Mr. Wickham:

I had a conference call this morning which included myself, Jan Wagoner (Delta engineer), and Mr. Bill Borgh (ConocoPhillips). We discussed the up coming work at the above referenced site. The cost of the up coming work is significant and we wanted to discuss it before we proceed.

We would like to propose a change in the current scope of work. It is clear that there are data gaps concerning the intermediate and deep groundwater bearing units at this site. To the best of our knowledge, the eight proposed monitoring wells to be installed in these two units will likely fill these data gaps. However, before we install any additional injection wells we would like to obtain the data from the eight proposed monitoring wells, including a least two quarters of groundwater monitoring data. This way we can use the data from the new wells to better design the remediation system. This would likely help to reduce the costs and shorten the remediation time.

Please let me know if this is acceptable to you.
