Jerry:

I have completed the Case Closure Summary Form for the site referenced above. I sent this to Estes' east coast consultants for review and comment. Matt Bramblett sent me the following questions.

- 1) Is Estes listed as a PRP for this site?
I could not answer this question. G.I. Trucking and Estes formed a partnership in 2001, so I assume (perhaps by default) that Estes is a PRP. At any rate,
We have been contracted with Estes (only) to conducted work at the site since February 2007. The reports through 2005 are directed to Arkansas Best Corp, and titled as G.I. Trucking Facility. Can you definitively answer Matt's question for me?
- 2) His second question was, What does the Regional Board notification mean and when does it occur?
Section VII of the form is, per my understanding, filled out by you (or ACEHS) as you discuss your recommended closure with them. Is that correct?
- 3) His last question is in regards to when the wells are destroyed.
I told him previously that wells are destroyed after concurrence within ACEHS and with the RWQCB that the site can be closed. Can you confirm this once more for me? I cannot see abandoning the wells before confirmation of closure is received.

Can you respond at your earliest convenience to these questions? I'd like to give Matt ACEHS' answers sometime later today, if that's possible.
