Kathy,

I've reviewed the proposed boring 6 location and am of the opinion it may make a suitable replacement location for boring CPT-05, especially moving it to the west as far as possible. However, by moving CPT-06, it creates a large gap between CPT-02 and the proposed relocation of CPT-6. I see from your Figure 3 entitled Proposed CPT Boring Locations, that there was an MW-4 (BP site) along Buena Vista Avenue. This would be a good location for a re-located CPT-5. If a monitoring well could be installed there, I would think a CPT may be advanced there as well.

Let's discuss.

Keith,

As we discussed, ARCADIS will be advancing one more location (CPT-06) to complete the scope of the Offsite Delineation Work Plan. We revised the location due to the presence of utilities (including a gas line) along Buena Vista. This location will only have hydropunches advanced due to the limited area for a CPT rig. A direct push rig will advance the hydropunch for collection of 4 depth discrete water samples (25-29, 30-34, 35-39. And 40-44 feet bgs). The CPT-06 field work is scheduled for Friday October 31, 2015.
