Keith,

As we discussed last week, there have been many utility challenges with the proposed locations. We are set to start the initial phase of the investigation on Monday September 22. We will be expediting the laboratory analytical to 5 days (standard is 10 days). We have a due date for a report on September 28<sup>th</sup> and will not be able to make this deadline. We can however provide draft tables and figures by October 7<sup>th</sup> for discussion purposes and if the contingency locations will need to be advance. A final report can be prepared within 45 days of receipt of analytical. This date will vary if we need to advance the 2 contingency borings (CPT-05 and CPT-06). As with all field events, ACEH is invited to stop by. I request you that you have level D PPE donned prior to entering the work zones.
