It's been years since any drilling was done at this site and, as you know, this was well before my involvement with this file. I will work to identify exactly what is required as quickly as I can.

I will review your letter and be back in touch to discuss next steps. This email message is to confirm receipt of your transmittal and acknowledge that I share your desire to bring this case to its appropriate conclusion. I believe there may be considerations that will factor in this regard, issues that were not identified in your letter. For the sake of a coherent

path forward, all issues, attributes and the history of the case activity with respect to deliverables, risk and oversight should be reviewed.
