I have extended the submittal deadline to Friday June 26 to help Chevron determine a path forward at the site. Please recognize that no changes have occurred in site environmental data since the August 26, 2014 letter requesting the Site Management Plan (SMP) and that Chevron has been attempting to identify a path forward for nearly nine months, including previous meetings with the Chevron real estate management team. Please also be aware that land use changes can occur after case closure and that SWRCB policy requires LOPs to progress all cases equally.
