


At the request of Ms. Juliet Shin of the Alameda County Health Care Services Agency (ACHCSA), Gettler-Ryan Inc. (GR) has prepared this work plan addendum to the GR's Work Plan for Limited Subsurface Investigation, dated October 30, 1998 for the subject site. The purpose of the work plan was to evaluate whether soil and groundwater downgradient of the subject site has been impacted by petroleum hydrocarbons, and whether developing the site would constitute a risk to human health. The scope of work was developed during a meeting between Tosco Marketing Company, ACHCSA, and GR representatives at the site on October 20, 1998. The purpose of this work plan addendum is to address the issue of whether underground utilities in the vicinity of the proposed groundwater monitoring well locations could influence groundwater flow and therefore influence the validity of the future groundwater sample analyses from these wells.

## Placement of Off-site Monitoring Wells with Respect to Utility Pathways

GR proposes the installation of three additional off-site monitoring wells, as shown on the attached Site Plan, Figure 2. These wells are intended to replace onsite monitoring wells MW-2 through MW-5 to facilitate site redevelopment. MW-2 through MW-5, damaged during site demolition activities, were destroyed on September 16, 1998.

Since the April, 1993 groundwater monitoring event, the shallowest depth to groundwater in monitoring wells MW2 through MW5 occurred in January, 1997, and ranged from 7.7 to 9.5 feet below the tops of the well casings (TOC). The maximum depth to groundwater in these wells since April, 1993 ranged from 10.86 to 12.98 feet below TOC. During the recent July, 1998 monitoring event, the depth to ground water in these wells ranged between 9.53 and 11.70 feet below TOC.

A map of storm drain and sanitary sewer utilities in the downgradient vicinity of the site were obtained from the City of Oakland Engineering Department (COED) and reviewed. A copy of a portion of this map showing the subject site and vicinity is attached to this work plan addendum.

Work Plan Addendum - Tosco 76 Branded Facility No. 1871 November 9, 1998

A storm drain lateral is located beneath the sidewalk area on the east side of MacArthur Boulevard, between the subject site and the proposed well locations. Based on measurements made onsite at the storm drain invert, and on street grade and flow line elevations obtained from the COED, the storm drain lateral is less than five feet below ground surface. Therefore, since historically the groundwater has not been shallower (since April 1993) than 7.7 feet, groundwater flow upgradient of the proposed well locations is unlikely to be affected by the storm drain lateral.
