Under ACPWA requirements there should be almost nothing to dispose except what can go into any dumpster: the "Christy box" and one drum's worth of auger cuttings from the portland cement well seal. These don't demand any particular special handling. If there is waste disposal, then two weeks are needed for lab analysis and five weeks for a landfill to turn around the paperwork; that makes waste disposal records not available until near the end of March.
