ACEH would like to close this case, however as I indicated in our email correspondence dated May 31, 2013 we have been dealing with a non-responsive responsible party. In lieu of this, ACEH conducted a query of the Enterprise Geographic Information System (EGIS) database to identify the addresses of the commercial and residential units of the mixed use properties located adjacent to the site, however, due to recent parcel splits the addresses are unavailable. On June 10, 2013 we sent an email to Mr. Walter Sprague with Pacific Convenience & Fuels requesting that he contact the owners of the properties and provide ACEH with the requisite addresses of the tenants.

As of today, we still have not received a completed Landowner Notification Form as requested by ACEH nor the requisite information regarding the list of recipients.
