On behalf of the Port, we have attached the information requested during our meeting yesterday. The following files are attached:

1. Vision 2000 with TOFC and UPMF RWQCB Directive. This attachment shows incorporation of UPMF and TOFC into the Vision 2000 requirements.

2. UP Roundhouse SMP.

3. EF6-EF9 Well logs. These well logs are from the EF6-EF9 UST cluster. They are monitoring wells MW-1, MW-2, and MW-3 that were installed by Geomatrix after UST removal and subsequently removed by the Port as part of the APL Terminal redelopment program. The top of the wells screens were about 3 feet below ground surface. and groundwater was encountered from 5.5 to 6.5 feet below ground surface. The screens were therefore appropriately placed to detect free product, if any.

4. County 11.14.05 letter. This letter from the County to the POrt indicates that no further work appears necessary at UST EF14 (Item 4 in the letter).

5. ETIC 2005 Risk Assessment excerpts re:95% UCL. While this item was not on your list in the email below, we thought that Dilan was interested in the methodology used in the development of the 95% UCL by ETIC in the 2005 risk assessment. They used ProUCL as described in the excerpt attached.

6. Vision 2000 Order #99-055.
