Good morning Mr. Nowell. As discussed, Amec Foster Wheeler (formerly AMEC) on behalf of the Port of Oakland, is requesting a revised submittal date for the Soil and Groundwater Investigation Report (Report) associated with the RO470_Final APL Terminal Work Plan_2014-11-07. The field investigation was initiated shortly after receipt of County comments on the Work Plan. However, to perform the field work in the safest way possible, the Port has limited the field work to a maximum of two days a week when the investigation areas are less impacted by Port activities such as ship un-loading and cargo movement. This will delay completion of the field work and completion of the Report.

Amec Foster Wheeler is requesting a revised submittal date of August 7, 2015. The new due date includes some additional time in case there are other delays associated with Port operations.
