ACEH has completed evaluating the subject site for closure as requested. However, based on the concentrations of contaminants detected in soil and groundwater, the site does not appear ready for case closure at this time. A letter detailing our comments has been prepared and will most likely be mailed out next Monday. In the interim, please continue semi-annual groundwater monitoring at the site or propose and justify an alternate monitoring schedule for review.
