Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."

2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."

3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."

4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

Existence of Unauthorized Release

A bakery has operated on the property, located at 3924 Market St., Oakland, CA 94608, since at least 1957 through the late 1980s. A site assessment conducted in conjunction with removal of a 500-gallon fuel underground storage tank (UST), product lines, and fuel pump in March and June 1991 revealed maximum soil concentrations of 210 milligrams per kilogram (mg/kg) total petroleum hydrocarbons as gasoline (TPH-g), 4.7 mg/kg TPH as diesel, 0.4 mg/kg of benzene, 0.6 mg/kg toluene, 1 mg/kg ethylbenzene, and 2 mg/kg totally xylenes. These concentrations indicate an unauthorized release has occurred from the underground storage tank system at this site.

Responsible Party Identification

Toscana Baking Company was the property owner since at least March 1969 through June 1993. Toscana Baking Company meets the definition of a responsible party for the site because it owned or operated an underground storage tank used for the storage of any hazardous substance (Definition 1); it owned the property where an unauthorized release occurred (Definition 3); and it had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance (Definition 4).

Through a series of mergers and acquisitions, Toscana Baking Company was acquired by the San Francisco French Bread Company (SFFB) circa 1984. The SFFB was acquired by Specialty Foods Corp. (SFC) circa 1993 and SFFB was managed by SFC's baking subsidiary, Metz Baking Company (Metz). Prior to and through SFC bankruptcy proceedings (circa 2000, handled by the law firm Skadden), SFC divested and sold Metz to Earthgrains Company, circa 1999. SFFB, managed by Metz, a SFC subsidiary, was divested from Metz and sold to Hostess Brands, Inc. (Hostess) (d/b/a Interstate Brands Corporation, and/or Interstate Bakeries Corp.) in 1997 prior to the SFC bankruptcy; however, the real estate parcel associated with the SFFB subject case was not part of the Hostess asset purchase agreement as attested by their legal department in letters dated October 5, 2010 and March 8, 2011. San Francisco French Bread Company (inclusive of: Specialty Foods Corp., Metz Baking Company, and Earthgrains Company through mergers and acquisitions) meets the definition of a responsible party for the site because they owned or operated an underground storage tank used for the storage of any hazardous substance (Definition 1); they owned or operated the underground storage tank immediately before the discontinuation of its use (Definition 2); they were the owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3); they had or have control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance (Definition 4).

SFFB (led by the Giraudo family of Boudin Bakery) acquired multiple bakeries including Toscana Baking Company, Colombo Baking Company, and Parisian Bakery. Of the four SFFB bakeries, only Andre-Boudin Bakeries (Boudin), currently exists. During SFC bankruptcy proceedings circa 2000, Jefferies & Co., Inc. (currently Jefferies LLC) handled the acquisition and sale of Boudin wherein the Giroudo family (originally part of the SFFB companies prior to acquisition by SFC) re-acquired the Boudin bakery in 2002. Andre-Boudin Bakeries (through acquisition of SFFB) meets the definition of a responsible party because it owned or operated an underground storage tank used for the storage of any hazardous substance (Definition 1); it owned or operated the underground storage tank immediately before the discontinuation of its use (Definition 2); it had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance (Definition 4).

Title of the property was acquired by Scott C. Atthowe in June 1993. Ownership of the property was transferred to the Scott C. Atthowe Trust in July 1996. Scott C. Atthowe and Scott C. Atthowe Trust are named as responsible parties because they own the property where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3).

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please SWRCB visit the website for more information on these requirements (http://www.waterboards.ca.gov/water issues/programs/ust/electronic submittal/).

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Please <u>do not</u> submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection.
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the document will be secured in compliance with the County's current security standards and a password. Documents with password protection <u>will not</u> be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:
