I do not believe there is a need to sample all of the wells for the fourth quarter, but please gauge all of the wells so you can include the contours and gradient in your fourth quarter report. Please continue gauging all wells every quarter that monitoring is performed. The due date for the SWI is October 26, 2009. If you have the groundwater results by then you can include them in that report, submit a separate quarterly report, or request an extension so you can combine the two reports.

Also, per Resolution 2009-0042, if you feel that continued quarterly monitoring is warranted, provide a letter with your justification and upload it to both ACEH's ftp site and Geotracker.

Hi Barb,

As you know, we just finished installing 8 new wells at Former Exxon Service Station 73006 (720 High Street, Oakland). We already submitted the third quarter 2009 sampling report. Since the new wells are required to be sampled quarterly, would you like us to sample <u>all</u> wells at the site during fourth quarter 2009 just for the assessment report? We are currently scheduled to sample all wells during first and third quarters, and only the new wells during second and fourth quarters 2010 (the first year after their installation) and from 2011 forward, all wells will be sampled semi-annually during first and third quarters. In our work plan we had proposed submitting the assessment report after a quarter of sampling, and I think the report would give a more complete picture of the site conditions if we included results (and gradient) from all wells at the site; however, if you think it would suffice, we'll submit the assessment report with just the sampling results from the new wells and then the first quarter 2010 M&S report will be the first report with results and gradient from all wells at the site.
