PUBLIC NOTIFICATION OF POTENTIAL CASE CLOSURE SHELL #13-5765 March 31, 2010

Site Location: 29 Wildwood Avenue, Piedmont, CA 94610 Fuel Leak Case RO0000495 and Geotracker Global ID T0600101246

Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case at 29 Wildwood Avenue in Piedmont, California (see attached map on back). Site investigation and cleanup activities have been completed and it does not appear that the fuel release presents a risk to human health for nearby residents or site workers based upon current land use. Case closure will be granted for commercial land use only. Site investigation activities, which have been conducted at various times since 1988, have defined the extent of petroleum hydrocarbons in soil and groundwater beneath the site. Groundwater monitoring has been conducted since July 1989 using 5 groundwater monitoring wells at the site. The groundwater monitoring data indicate that the concentrations of petroleum hydrocarbons in groundwater have decreased since 1988 and that water quality is expected to be restored to water quality objectives through natural attenuation processes within a reasonable period of time. During the most recent groundwater sampling event in August 2009, the maximum concentration of methyl tert-butyl ether (MTBE) detected in groundwater beneath the site was 17 micrograms per liter (parts per billion). Groundwater contamination from the site will not affect the nearest water supply well which is located approximately 2,500 feet northeast of the site.

Background –. The site, which is located at the corner of Grand Avenue and Wildwood Avenue in Piedmont, California (see attached map on back), has operated as a gasoline service station for more than 25 years. A release of gasoline from the fueling system was discovered following tank removal and replacement operations in 1984. Groundwater monitoring wells were installed in 1989. Fuel system components consisting of the dispensers and product piping were upgraded in March 1998 and April 2005. Site investigation activities consisting of soil and groundwater sampling were conducted at the site at various times between 1988 and 2009.


