Hi David,

I got your voice mail, and can talk, but thought I'd start with responding to your email.

I did a VERY quick check of our files and did not see anything; however, it was a VERY limited check. That said, you should go to our website (see link below my name / signature), or you can go to Geotracker as pretty much our entire file was uploaded to Geotracker so that it would be readily available. I would recommend you review the "CORRES" file, which has correspondence / communications from Oct 10, 1993 to October 26, 2006 from our files (was a single scan when we converted from paper to electronic files).

Regardless, Mr. and Mrs. Gracio would be considered to be an RP by the State using the four definitions required by the State to be used when identifying RPs. At a minimum they would meet the simplest form, that of property ownership. I see that the NOR (the old "Notice of Requirement to Reimburse", rather than more recent form called by the State "Notice of Responsibility") did not get uploaded back in the day, so have attached it for your use and for you to upload to Geotracker since you are now managing the case. Likely it will need updating based on any property transactions since then. ACDEH definitely would not have removed the Gracio's from being RPs since they meet at least one of the definitions required to be used. Our referral letter is the last item in our files, dated March 22, 2012.
