### Dear Responsible Parties:

Alameda County Environmental Health (ACEH) is reviewing the fuel leak case for the above referenced site for case closure. As you are aware a site investigation and groundwater monitoring for underground storage tank leaks has been performed at the subject property to which you are named as the primary or active responsible party.
