Dear Ms. Gatzke and Mr. Ghassemi:

Alameda County Environmental Health (ACEH) staff has reviewed the fuel leak case file for the abovereferenced site. Additional investigation or cleanup is not necessary at this time unless requested by ACEH during closure review. Based upon the results of the case closure review, ACEH will either request that the existing monitoring wells be decommissioned in anticipation of case closure or will request additional work at the site.

Pursuant to Section 25297.15 (a), Alameda County Environmental Health (ACEH), the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACEH is required to notify the primary or active responsible party of their requirement to certify in writing to the local agency that the notification requirement in the above-mentioned regulation has been satisfied and to provide the local agency with a complete mailing list of all record fee title owners.

To satisfy the above-mentioned requirement, please complete the enclosed "List of Landowners Form," and mail it back to ACEH within thirty (30) days from the date of this letter. Also your comments must be considered prior to the proposed cleanup or closure. Please respond within 30 days from the date of this letter for your comments to be considered.

In accordance with the Public Participation requirements in the California Code of Regulations Chapter 16, Section 2728 Article 11, ACEH has prepared a Fact Sheet that will be distributed to land owners and occupants of surrounding properties. A copy of the Fact Sheet is attached. Public comments on proposed case closure as described in the attached Public Notification of Potential Closure of Fuel Leak Case will be accepted until August 3, 2010. 

Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case at 1499 MacArthur Boulevard in Oakland, California (see attached map on back). Site investigation activities have been completed and it does not appear that the fuel release presents a risk to human health based upon current land use. Site investigation activities, which have been conducted at various times since 1993, have defined the extent of petroleum hydrocarbons in soil and groundwater at the site. A soil vapor extraction (SVE) system operated at the site from April 2000 through April 2001. Soil vapor sampling conducted in January 2007 and August 2009 indicates that subsurface vapors do not pose a risk of indoor vapor intrusion to current site users or residents of nearby properties. Due to the residual contamination remaining in the area of the former USTs, case closure for this fuel leak site would be granted for the current commercial land use and the existing building only.

Background – The site is currently an auto repair facility. The site operated as a gasoline service station and/or auto repair facility from 1941 until 1990. On October 2, 1990, one 500-gallon and two 1,000-gallon gasoline underground storage tanks (USTs) were removed. The three USTs were located within a bottomless concrete vault. During removal, petroleum odors and soil discoloration were observed in the area of the USTs and soil samples collected during the 1990 tank removal indicated that soil contamination was present in the area of the former fuel system. After the USTs were removed, the concrete vault was backfilled and the area was covered with concrete. Site investigation activities consisting of soil and groundwater sampling were conducted at the site in 1993, 1996, 2006, 2007, and 2009. During operation of a SVE from April 2000 through April 2001, approximately 16.5 pounds of petroleum hydrocarbons were extracted in vapor recovered from the subsurface. Soil and groundwater sampling conducted from 2006 to 2009 indicates that petroleum hydrocarbons remain in the area of the former concrete vault. Groundwater monitoring that was conducted from 1993 to 2009 indicates that the concentrations of petroleum hydrocarbons in groundwater beneath the site do not pose a risk to current occupants of the site or nearby residents. The concentrations of petroleum hydrocarbons in groundwater beneath the site do not pose a risk to current to be decreasing and further restoration of groundwater quality is expected to take place by natural attenuation processes.

Next Step – The public is invited to review and comment on the potential closure of the fuel leak case.
