The referenced site is a Site Cleanup Program (SCP) case due to the presence of soil and groundwater contamination at the property. Alameda County Environmental Health (ACEH) is the agency providing regulatory oversight for this case. As discussed in the meeting of December 12, 2014, in order for ACEH to complete the regulatory review and closure process, we require an additional deposit to an oversight account. Previously incurred costs of approximately \$1,500.00 have accumulated that have not been paid. An additional amount of \$2,000 was requested in the meeting to provide further for planned activities in the near future. Please send a check in the amount of \$3,500.00 payable to Alameda County Environmental Health. Please send your check to the attention of our Finance Department.

This deposit may or may not be sufficient to provide all necessary regulatory oversight. ACEH will deduct actual costs incurred based upon the hourly rate specified below. If these funds are insufficient, an additional deposit will be requested. Otherwise, any unused monies will be refunded to you or your designee.

The deposit is authorized in Section 6.92.040L of the Alameda County Ordinance Code. Work on this project is being debited at the Ordinance specified rate, currently \$204.00 per hour. Please write "SCP" (the type of project), the site address, and the account ID AR0322546 on your check.
