This letter confirms a telephone conversation between Alameda County Environmental Health, Hazardous Materials Program and Mr. Ron Richmond, of Property Contamination Control, Inc., held on September 19, 1988, to discuss the ongoing site evaluation of 1033 - 44th Ave., in Oakland.

In accordance with Regional Water Quality Control Board's guidelines, the installation of ground water monitoring wells will be required to assess your degree of ground water contamination by petroleum hydro carbons. You are required to submit a proposal that delineates your approach to identifying ground water movement and also shows the intended geographical placement of monitoring wells.

Well sampling and sample analysis will be required on a quarterly basis. The results must be submitted to all regulatory agencies.

Please be aware, the lead agency for this project is the Regional Water Quality Control Board and as such, final evaluation and site sign off is their responsibility.

Please be advised that the oversight of the remediation of the above site has been transferred to the Local Oversight Program (LOP) section of Alameda County Environmental Health, Hazardous Materials Division. Our office has reviewed the files regarding the removal of the 1000 gallon diesel tank from the above site. These files include the tank closure results, results from the overexcavation of the tank pit, the installation of one monitoring well in the assumed downgradient location and four quarters of groundwater monitoring. At this time our office would propose to recommend this site to the Regional Water Quality Control Board (RWQCB) for case closure. Prior to doing this, you are required to provide a report to both this office and that of the RWQCB which includes the appropriate items from the attached guideline. This letter was developed by the RWQCB to provide uniformity, to expedite their review and to insure concurrence for site closure.
