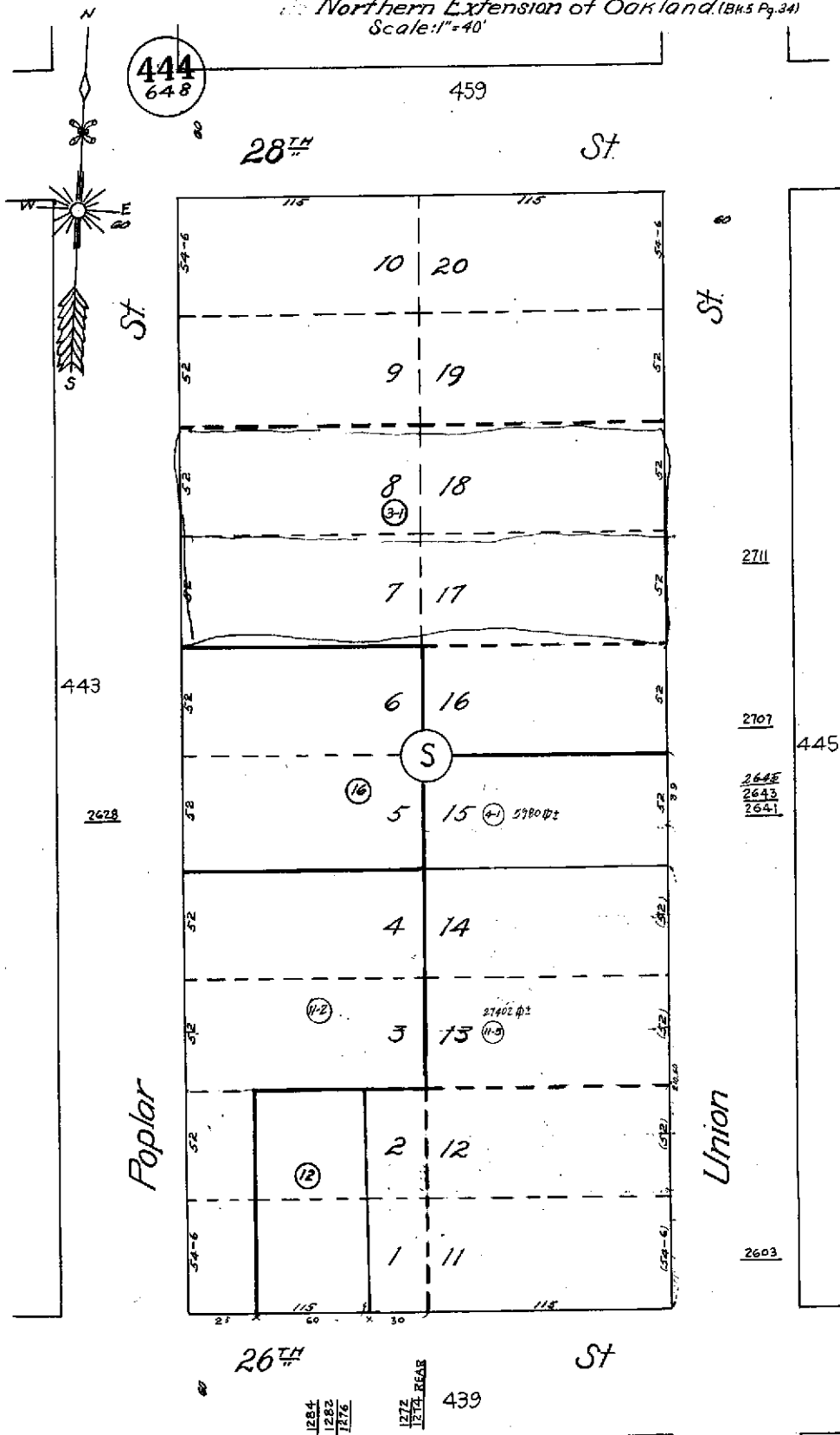


Map of survey of
