## Hi Jim.

You are correct, it appears that the case on Geotracker has been claimed and a report has been uploaded (to upload a case, it needs to be claimed first). Also EDF data would not be required prior to 2005. Beyond that point I can't offer much assistance as I have no funds to work from. You'll need to review the documents to see what appears to be appropriate. The LTCP can be used for petroleum cases, but my recollection is that potential contamination at the site will be close to the surface and not evenly distributed, so contaminant distribution characterization could be difficult. I also presume that there may be engine (or used) oil associated with the case; which may complicate the site as it is not just petroleum only.

I should probably update the funds request letter as the hourly has increased several times since the 2009 letter was sent. It is now \$204/hr, and the \$4,000 amount allows less time to review the site; however, I can keep it at that level to see if we can get the case closed with limited work (but my understanding of the site may be incorrect, so please understand that is not a promise).

Hi Mark,

David Weiss of AAA Truck Parts has retained CDMS to address their groundwater monitoring project, which is outstanding with the County.

In reviewing some of the background material I have reviewed your letter of July 24, 2009, where requested that site must be claimed and the analytical data must be uploaded to the GeoTracker system. Wells were installed and the initial sampling was conducted, and a report was prepared on July 15, 2003 by EnGeo Inc, AAA's consulting firm at the time. This report was apparently uploaded to GeoTracker by Paul King of RGA Environmental. The requirement to upload EDF analytical data was not required by the State until 2005, so it is my conclusion that the July 15, 2003 upload met the initial requirements to claim the site and provide the

analytical data. There is still the fact that multiple samplings events have not occurred, which was part of the approved Work Plan that was approved in August 2002.

What do you suggest we do from this point forward to finalize this project?
