Alameda County Environmental Health (ACEH) is reviewing the fuel case file for the above referenced site for potential case closure. As you are aware a site investigation and groundwater monitoring for underground storage tank leaks has been performed at the subject property to which you are named as the primary or active responsible party.

List of Landowners Form

Pursuant to Section 25297.15 (a), Alameda County Environmental Health (ACEH), the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACEH is required to notify the primary or active responsible party of their requirement to certify in writing to the local agency that the notification requirement in the above-mentioned regulation has been satisfied and to provide the local agency with a complete mailing list of all record fee title owners.

To satisfy this requirement, please complete the enclosed *List of Landowners Form*, and mail it back to ACEH by the date identified below. Also your comments, if any, must be considered prior to the proposed closure. Please respond within 30 days from the date of this letter for your comments to be considered.

Public Participation

Public participation is a requirement for the Corrective Action Plan and case closure process. In order to notify potentially affected members of the public of the potential fuel leak case closure, ACEH has distributed the attached *Notification of Potential Case Closure* to addresses in the immediate vicinity. The *Notification of Potential Case Closure* requests that landowners or residents submit any comments or questions to ACEH regarding potential case closure by June 14, 2013. ACEH will consider all comments from the public prior to potential case closure.

NOTIFICATION OF POTENTIAL CASE CLOSURE Clamp Swing


Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a fuel leak case at the business located at 2515 Blanding Avenue in Alameda, California. The site was reportedly operated as a light manufacturing plant until 1998 and was remodeled for use as a mixed commercial/residential development.

On September 15, 2002, one 300-gallon underground storage tank (UST) was removed from the sidewalk. There were no visible holes in the tank, but odor and visual evidence of impacted soil was noted in both the overburden soil and soil beneath the tank. Contaminated soil was overexcavated. Up to 105 parts per million (ppm) TPH as diesel (TPHD) was left in place in the eastern side wall of the former tank pit after overexcavation. Up to 8500 parts per billion (ppb) TPHD was detected in a grab groundwater sample.

Residual soil contamination appears limited to an immediate area adjacent to the location of the former UST and dissolved phase contamination appears limited in extent and is anticipated to naturally degrade over time. The residual petroleum hydrocarbons present in groundwater and soil are considered not to be a threat to public health, safety, or the environment. Site investigation activities have been completed. Therefore, ACEH is considering potential closure of the fuel leak case.

Next Step – The public is invited to review and comment on the potential closure of the fuel leak case.
