Dear Mr. Bowen,

This correspondence is to confirm our conversation of June 12, 2015, made in response to Alameda County Environmental Health's (ACEH) request to continue with coordinated groundwater monitoring with the adjacent UNOCAL station located at 3420 35th Ave. During the conversation it was indicated that the quarterly groundwater monitoring event for the subject site was already performed, ahead of the event for the UNOCAL station.

Please continue to present the data from the UNOCAL station site with your groundwater monitoring report. As there may be a disconnect in the depth to water data due to the passage of time, please plot the groundwater elevation contours independently for each site.

Please provide the subject case groundwater monitoring report, incorporating the data from the UNOCAL station, within 30 days after receipt of the data for the UNOCAL station.

ACEH requests future groundwater monitoring events for the two sites be coordinated if both sites remain open cases.
